## Community Service in Action!

When Marilyn Rubin was asked to help the Fifth Grade Girl Scout Troop plant two gardens at Cornerstone School in RPV, she contacted Bill Petitt for assistance. Petitt manages the veggie garden at Riviera Elementary School. On October 24th, he brought lettuce, cabbage and broccoli seedlings and helped the girls plant a winter garden and colonial garden. They pulled out all the old plants and cut them up to make a compost pile, then added organic material before wetting the soil. The girls loved using their hand tools to mix the water and amendments into the cleared beds. Then, they planted the seedlings at the proper depth, as demonstrated by Petitt. As a reward, Marilyn gave each girl a 4" pot, which they filled with moistened soil and lettuce seeds, thus bringing home the "fruits" of their labor!

# Compliance Corner By George Unrine A Little About Non-Profits

"Non-profit" is usually used to describe an organization that is not intended to provide financial benefit to its shareholders. You come in contact with non-profit organizations when you go to a thrift shop, belong to the Y, attend church, donate to a worthy cause, or, belong to a garden club. They are all around us. The one thing they all have in common is that they are not required to pay

federal or state income taxes. An organization does not need to be incorporated to be considered a non-profit.

While non-profits do not pay income taxes, they are subject to reporting requirements. Since 2006 all non-profit organizations have been required to file a yearly Statement of Information with the IRS. A similar requirement was put in place in 2010 by the California Franchise Tax

Board. The questions asked in the Statements' of Information allow the IRS and FTB to determine if an agency is acting like a non-profit. Failure to file could cause the IRS or FTB to declare an organization to be for-profit and subject to income tax.

I am happy to report that because of our relationship with CGCI, Riviera Garden Club was aware of these requirements and has submitted the required filings with the IRS and FTB.
